THE PROGRAM AND GENERAL INFORMATION

The Association CORRI LA VITA onlus, in collaboration with LILT (the Italian League for the Fight against Cancer - Florence Section), and the Amateur Sport Association Firenze Marathon, organize this physical recreational event, offering 2 itineraries; 1 of approx. 11 km, and the other of approx. 5.5 km through the city of Florence and its surrounds.

THE DATE AND THE MEETING PLACE FOR THE 17th edition of CORRI LA VITA onlus

It will take place in Florence on Sunday 29th September 2019, with a starting place of Piazza Vittorio Veneto and with a departure time of 8.45 a.m.

HOW TO PARTICIPATE IN THE WALK OR THE RUN

CORRI LA VITA onlus is a recreational and not a competitive event. It is open to everyone. There will be no chip timing, nor any form of classifications, consequently and there will be no prize giving. Please note it is important that each participant follows the rules and codes of a public road.

REGISTRATION:

Registration opens on September 2, 2019

Registration and participation locations for CORRI LA VITA onlus are listed on the website www.corrilavita.it

We do not accept registration over the telephone, nor do we accept participants who have not paid the registration entry fee.

Minors (under the age of 18 years) must fill out a registration form. This form must be signed by a parent or legal guardian.

Children under the age of 5 years may participate free of charge (without an official T shirt) but having completed a registration form with the signature of a parent or a legal guardian. The parent or legal guardian must also be registered and obtained the bib number. This registration is obligatory for a child to participate in the event.

Dogs may participate but they cannot enter in any of the cultural points of interest offered (churches palaces, parks and galleries etc) during the course of the event .

Registration is possible up to the morning of Sunday September 29th only if bib numbers are available.

The minimum donation to participate is €10.00 (euro 10.00)

The prize for every participant is a cotton official T shirt, offered by the Salvatore Ferragamo SpA. They will be available together with the bib numbers until supplies last.

STORAGE DEPOSIT

There will be a designated cloak area, where personal belongs may be stored till 12.30 p.m. and not beyond. This service is only available for registered participants with the bib number for the long itinerary (yellow). For your convenience the storage service will be in the vicinity of the starting/arrival line in Piazza Vittorio Veneto.

WASHROOM AND TOILETS

There will be chemical bathrooms at the starting and finish line in Piazza Vittorio Veneto

MEDICAL ASSISTANCE

Will be available and will be administered by the Misericordia Fiorentina (the confraternity of volunteers to help the needy), and in collaboration with ANPAS (the association of National Public Assistance).

RESPONSIBILITY

The association of CORRI LA VITA onlus will only accept original registration forms, filled out completely and legibly, and signed by the participant.

The association of CORRI LA VITA onlus together with all the collaborating companies and institutions involved in this event, are exonerated from any responsibility for any eventual damage or expenses (including legal expenses) that may derive from result of an accident and/or because of one's personal state of health and/or because of another persons' behaviour that may damage the participant and/or the belongs of such, during this sporting event.

Completing the registration form the participant declares that he/she fully understands and assumes the responsibility for the rules and regulations stipulated for this event, and also declares and except those regulations that may not here be stipulated by CORRI LA VITA onlus.

With the registration to CORRI LA VITA onlus, the participant declares that he/she knows and accepts

the rules and regulations of FIDAL (Italian Federation of Athletics) and also fully understand that it is obligatory to wear the bib number as a sign of one's registration, and accepts that without this recognition the participant will be excluded from the event.
